**IMPORTANT**: Exchanged product will be covered by limited warranty for the balance of the original limited warranty period only.

- 3. During the limited warranty period, Estron Marketing Pte. Ltd. will exchange without charge for parts or full product and labour, a materially defective product with a new or refurbished product on a ONE-TO-ONE-EXCHANGE basis. The consumer will be guaranteed with a product that is in its full working condition. The materially defective product will be retained by company.
